## VCSU's V-500 Scholarship Program Celebrating 40 Years 1972-2012

The Valley City State University V-500 Scholarship Program will be 40 years old in 2012. Founded in 1972, V-500 has played and continues to play an important role in attracting students to the University. A total of \$15,000 was raised in the first year of the program. Several scholarships in the amount of \$75 were awarded to needy students. Since that time, total scholarship allocations have grown to over \$250,000 for the current academic year. Scholarships range in size from \$1,000 to \$2,500. According to Charlene Stenson, Director of Enrollment Services at VCSU, "The V-500 program has been a major factor in our ability to attract students to the University. Time and time again, we are able to outpace our competition because of the V-500 Scholarship Program." There are well over 1,000 V-500 members. Many have multiple memberships and a growing number have supported the program at the V-\$5,000 and V-\$10,000 levels.

The V-500 Board of Directors is currently engaged in their annual membership drive. Basic membership in the program requires a \$200 commitment for a five year time period. Membership comes with attractive gifts and two free tickets to the annual V-500 Recognition Banquet scheduled for December 10, 2011. Following the banquet, all participants are invited to attend the EBC Alumni Association's "We're In The Christmas Mood Program" in Vangstad Auditorium later that evening.

According to Larry Robinson, Executive Director of University Advancement, "The V-500 Scholarship Program is an opportunity for all of us to assist a needy student with University costs. Total costs for attending one year at VCSU including personal expenses exceed \$14,000. **V-500 is an investment in our students, our university and our community.**"



Scholarship allocations for the 2011-2012 academic year reached an all-time record. Total allocations topped the \$757,000 level. This is an all-inclusive figure including V-500, Century, and Memorial and Endowed scholarships.

#### **Maximize Your Year-End Gift Benefits**

Generosity knows no season, but this is historically the time most people give and receive—and begin income tax planning. Here are some ideas on how to map out a plan for **making a difference** at Valley City State University.

**Give cash.** To document a cash gift of any amount, you must have a receipt from us prior to filing your return that amount, and whether you received any goods or services in exchange for your donation. Make certain you receive one. A cancelled check provides sufficient documentation only for gifts by check if they are less than \$250.

**Give stock or other property.** If the property has depreciated in value, sell it and deduct the loss to the extent allowed by law. Then donate the cash received from its sale. That way you have another deduction. If it is worth more than what you originally paid for it, do not sell it. Donate the property to us—we'll sell it and you will eliminate all the capital gains tax you would ha than one year.

With a gift to a qualified charitable organization such as VCSU, you can receive the greatest tax advantages when donating this year.
