## The Enrollment Picture at VCSU

As you can see by the front cover of this issue of *The Bulletin*, some major strides forward have been taken at Valley City State University with our enrollment initiatives. There is a wonderful story to share regarding VCSU's Fall 2010 student enrollment, and this news should make every supporter, alumni, and friend of VCSU very proud!

In Fall 2010, VCSU welcomed its largest class of freshmen to the campus since 1988. The large freshmen class (an increase in excess of 40% over last year's freshmen class), coupled with an increased number of transfer students, and a record number of graduate students in our Master's program, have resulted in VCSU's largest overall enrollment since 1970.

The really exciting news about the growth in enrollment this year is that

these gains are across the board and include virtually every demographic of student on the VCSU campus. The freshmen class is larger; we have our largest transfer student enrollment in seven years; the record Master's

fall 2007. This 30% growth in just the past three years represents truly meaningful growth that is incredibly positive for the entire VCSU campus. In fact, VCSU's growth represents the largest percentage increase in overall headcount as well as the largest percentage increase of Full-Time Equivalent enrollment by any campus within the entire North Dakota University System during the past year.

An increased number of students on the VCSU campus means more students are utilizing campus services such as the bookstore, dining services, and the residence halls. These increases are positive for the campus as we look to provide a broader array of campus services and opportunities for our students. The \$3.5 million Snoeyenbos Hall renovation currently underway during the 2010-11 academic year is

one such tangible example of these new benefits that will serve students. As we work to succeed with additional initiatives aimed at increasing VCSU's student enrollment, we look forward to providing

further services for the long-term benefit of future generations of VCSU students.

On a final note, thanks to all alumni and friends who came back to campus for Homecoming 2010 activities. Homecoming provided a great week of events for both our current and former students alike. It was great meeting many of you at the various activities. Enjoy this issue of *The Bulletin*, and I look forward to seeing you at future alumni and VCSU-related activities.

enrollment; an increase in enrollment of VCSU's elementary education students at NDSU; residence halls are at the fullest levels in several years; more students are taking classes at a distance via Internet and other technologies; both full-time and part-time student numbers are up significantly. Everywhere you look, the results are positive and contribute to the substantial overall enrollment growth.





## **Enrollment Soars... Scholarship Support Key**

We are often asked by our alumni and friends about happenings on the university campus. Folks

are interested in important campus issues such as enrollment.

new programs, faculty and staff and capital improvements. *The Bulletin* is our primary means of telling our story and keeping you abreast of the happenings on campus. To be honest, there are many exciting developments. There are capital improvements ongoing, new programs being added, and new faculty and staff joining our university family. But by far, the most exciting news on the campus is the 19% increase in enrollment! Yes, that is right. Our headcount now stands at 1,285. That represents the largest headcount since 1970 and the largest freshmen class since 1988.

What caused the spike in enrollment? There are a variety of factors that have impacted the enrollment growth. New programs, economic conditions, strong student satisfaction, and

certainly the availability of scholarship support. In fact, 64.6% of our freshmen indicated that

financial assistance was one of the leading factors in their decision to attend VCSU.

To that end, our

scholarship programs have been the number one priority of the VCSU Foundation and its member groups for many years. For the current academic year, the Foundation Board of Directors allocated \$750,000 in scholarship support for our students. This is an increase of over \$100,000 over the previous year. The impact is without question. The challenge now is sustainability.

We are in the midst of our V-500 scholarship program membership drive as I write this edition of the Foundation Corner. The V-500 program is the primary source of scholarship support for our students. V-500 was founded in 1972 by a handful of visionary leaders. The first year a total of \$15,000 in scholarship support was awarded with a typical scholarship

at the \$75 level. Today, V-500 is awarding approximately \$232,000 annually and scholarships range from \$1,000 - \$2,500!

V-500 boasts in excess of 1,250 members, many with multiple memberships. Some have contributed in excess of \$50,000 to V-500. Basic membership is available for \$200 per vear for a five year commitment. That amounts to just 54 cents per day - a small investment to have such a huge impact! We want to thank the many V-500 members for their support of this important scholarship program. Final headcount for Fall semester 2010 soared to 1,285, a 19% increase over last year. The last time that VCSU had a headcount this large was 40 years ago, and only twice in VCSU's history has headcount been larger (1969 and 1970).

The dramatic increase appears to have been driven by a combination of factors. New freshmen headcount at VCSU was 220, a 42% increase over last year and the largest since 1988. Add to this 90 transfer students (more than a 30% increase over last year) and you end up with a sizeable injection of new students.

According to VCSU president Dr. Steve Shirley, the increase in enrollment was spread across all corners of the University. "Total undergraduate headcount increased by 18%, and most of that increase was in full-time students. Headcount in our online Master of Education continued its record of steady growth every year since its inception in 2005, this year growing by 20% to 147. Total Full-Time Equivalent (FTE) enrollment increased by 15% over last year."

These increases are due to a number of strategic initiatives that the University has put in place to grow enrollment and increase opportunities for students.

One major initiative the University has had underway is to introduce new academic programs. For example, VCSU's Fisheries and Wildlife major,

which was introduced in 2005, has more than doubled in size since last year. The Health Science program, introduced in 2004, grew by more than 30% over last year.

New athletic programs are also contributing to the increase in enrollment. Cross Country and Track & Field are both having inaugural seasons in 2010-2011, and Men's and Women's Golf is entering its second year.

In addition, VCSU was recently recognized as a "Best College" by U.S.News for the 13th year in a row, and for the second year in a row, the University was the second highest ranked public college in the Midwest. According to Dr. Shirley, "This consistent affirmation demonstrates that VCSU is well-known for delivering an outstanding educational experience and that our reputation is continuing to grow."

"For several years now, we have been making strategic investments into key areas of the University with the intention of increasing enrollment," said Dr. Shirley. "We have increased our Enrollment Services staff so they can expand their recruiting efforts, and they have been doing an outstanding job. Marketing programs have increased awareness in areas we've identified as having high growth potential. All of this has contributed to our increased presence, and subsequently, our increased enrollment. We could not be more pleased with our progress in all of these areas."

## **What Brings Students to VCSU?**

### Financial assistance, low cost play key roles

The thought process that students go through when deciding on a college involves a lot of factors, but for VCSU, one of the most important appears to be our ability to offer financial assistance.

Every two years, freshmen at VCSU take part in a national study conducted by the American Council on Education that assesses several

characteristics of the students entering college, including factors that influenced their decision. According to the most recent

survey, conducted in 2008, the number one reason that VCSU's students identified as "very important" in influencing their decision was an offer of financial assistance.

For example, Tyler Martin, an Elementary Education major from Hawley, MN, said the scholarship he received played a large role in his decision. "It meant that I had a quarter of my college already paid for, and I am very appreciative of receiving it!" Tyler was awarded the President's Scholarship, a \$2,500 annually renewable scholarship for first-time freshmen. The scholarship is awarded based on a combination of academic achievement and ACT score.

Emily Waswick, a freshman from Gwinner, ND with a major in

Elementary Education, said, "The scholarships offered by VCSU meant I could get my degree without facing hefty college loans when I graduate. Small class sizes, individual help I could receive from the professors, and all the positive feedback I heard from current students also helped with the decision."

Athletic scholarships play a huge role, too. Raymond Jackson, a CIS major from Tampa, FL, and defensive lineman for the Viking football team, said, "My scholarship was a real help with tuition, and I appreciated the recognition for my hard work in high school. The people at this school understand me, and I'm happy

they gave me a chance to come here."

In all, VCSU increased scholarship awards by nearly 20% to more than \$750,000 for the 2010-2011 academic year.

"This leaves no doubt about the importance of scholarship contributions to our enrollment," said Larry Robinson, Executive Director of Advancement at VCSU. "Our alumni and donor base has been absolutely fantastic and has really stepped-up to the plate to help us maintain our scholarship base in the face of a very difficult economy, and we have received tremendous support from the community. But we need to keep it up − enrollment gains can quickly become losses if the support we get from our donor base is not sustained." ◆

## **Changing Profile of a Growing University**

Rapid growth like this is bound to change the profile of a university, and this year, VCSU is no exception. One notable change: the percentage of VCSU's freshmen class that are from North Dakota increased from 57% in 2009 to 65% this Fall semester. According to Dr. Shirley, "This is a pretty clear sign that we are doing a good job meeting the needs of North Dakota and its students."

The campus is also seeing an increase in diversity. Enrollment this Fall includes 37 students from 12 foreign countries, and non-white student population has steadily grown from about 10% in 2001 to nearly 15% in 2010. Nearly one-third of overall enrollment is age 25 or older.

While programs in education are still the most popular, new programs of study are also having an impact on VCSU's personality. On the undergraduate side, three majors in particular have shown dramatic growth in recent years: Fisheries & Wildlife Science (65 majors), Health Science (62 majors), and Exercise and Leisure Studies (40 majors). This growth is one of the factors driving the need for an expansion of the Rhoades Science Center, and VCSU has submitted a proposal for a \$10.8 million expansion and renovation that will be considered during the 2011 legislative session. Other new undergraduate programs include Professional Communication and Music with an Emphasis in Business. In all, 197 undergraduate students have declared majors that didn't exist at VCSU only 10 years ago. Another 147 students are enrolled in VCSU's Online Master of Education which has only existed since 2005. Overall, 27% of VCSU's current enrollment is involved in new academic programs. •

## **Bob King '55 Inducted into North Dakota Sports Hall of Fame**

Bob King, an integral part of sports in North Dakota for more than 50 years, has been inducted into yet another Hall of Fame. This time, it was the North Dakota Sports Hall of Fame into which King was inducted at their banquet in July.

This honor was actually Bob's eighth induction into a Hall of Fame. Previously, he had been inducted into the ND Officials Hall of Fame (1982), ND High School Coaches Hall of Fame (1985), Valley City High School Athletic Hall of Fame, VCSU Athletic Hall of Fame (1991), New Rockford High School Hall of Fame, ND Athletic Directors Hall of Fame (2003) and the ND High School Track & Field Hall of Fame (2009). He also served as

president of the North Dakota Sports Hall of Fame.

During his college career, he earned an impressive 13 varsity letters in basketball, football, baseball and golf. After graduating, he went on to earn his Masters degree from NDSU in 1970, then taught and coached in Pelican Rapids, MN (1955-56), Milnor, ND (1956-1960), New Rockford, ND (1960-1965), and Valley City (1965-1979). As a teacher, coach and athletic director for over 25 years, Bob led his teams to 15 football conference championships and

a state Class B Track & Field championship (1961), followed by two runner-up titles in (1962 and 1963).

While Bob has coached and played many different sports, football is his first love, as evidenced by his ND High School Coaches Association Class A Football Coach of the Year award (1974), two Distinguished Service Awards from the National High School Athletic Coaches Association (1975 and 1979), and the NDHSACA Region Six Football Coach of the Year award (1978). The North Dakota Coaches Association presented Bob with the Award of Merit in 1979. He served as the ND Officials Association president in 1978-79 and officiated 16 consecutive state basketball tournaments.

In 1979, Bob left his role as athletic director and head football coach at Valley City High School to become the assistant to the executive secretary at the North Dakota High School Activities Association. He served on the National Board of Directors from 1975-1979 and continued as NDHSADA president in 1978-79. He was recognized with Distinguished Service Awards from both the National Federation of Officials Association (1985) and the National Association of Athletic Administrators (1993). He received Awards of Merit from the University of North Dakota (1988) and the National High School Coaches Association (1999), a National Federation Citation (1998), and the Valley City State University Distinguished Alumni Award (1999).

Bob served on the National Federation of High School Association Rules Committees including the Track & Field, Football and Basketball Rules Committees. North Dakota was a pioneer experimenting with the three-point shot which was soon adopted for all Class A schools in North Dakota, then spread to other states, and finally across the nation. Now, the NCAA and professional basketball leagues also use the three-point shot.

In 1988, he became the Executive Secretary of the NDHSAA, a position he held until his retirement in 1999. In his twenty years at the NDHSAA, Bob supervised 25 extracurricular activities and managed a budget of over one million dollars. ◆

## Dr. Neil C. Gudmestad Recognized with Distinguished Alumni Award

Dr. Neil Gudmestad '74 was selected by the VCSU Alumni Board of Directors to become the 57th recipient of the Distinguished Alumni Award. The Distinguished Alumni Award was adopted by the VCSU Alumni Association to recognize alumni who have achieved prominence in their chosen field of endeavor. The nominee must have received national or international recognition and must have been identified as an expert in the individual's chosen field.

Dr. Gudmestad obtained his PhD in 1982 and joined the faculty at North Dakota State University in 1985 where he is currently a University Distinguished Professor of Plant Pathology. Prior to obtaining his degree he worked as a plant pathologist for the North Dakota State Seed Department, the agency within the ND Department of Agriculture responsible for regulating seed certification in the state.

He has conducted research on the diseases of potato for over 33 years. Dr. Gudmestad's

research program actively conducts research on a number of foliar and tuber diseases of potato that are soil or seed borne and he is principally interested in the biology, ecology and genetics of plant pathogens. His current research program is heavily involved in studying new and invasive plant pathogens affecting potatoes in the United States as a result of climate change.

Dr. Gudmestad has published over 300 peerreviewed articles, book chapters, technical papers and other publications over his career. He has successfully authored or co-authored research proposals in excess of \$25 million to fund agricultural research at NDSU, of which nearly \$10 million has directly supported his research program.

In 2007 Dr. Gudmestad was named one of the inaugural University Distinguished Professors at NDSU, the highest honor the University can bestow.



## **Women's Basketball Preview**

The Valley City State Viking women's basketball team has adopted the theme "Good to Great!" for the 2010-11 season. And they have been good! The Vikings have won at least 17 games and hosted a first round playoff game in the DAC tournament in three of the past four seasons. During that time, the Vikings received the program's highest national rank of 19th in the NAIA Top 25 poll (2008-2009).

Returning six players, including five seniors, the Vikings look forward to a unique opportunity to win the Dakota Athletic Conference Women's Basketball Championship during the 2010-2011 season. The Vikings return 59% of their offensive output (37.6 points per game) as well as 22 rebounds per game from a year ago. The Vikings add nine newcomers to the roster for 2010-2011 and have high expectations for the talented group.

"I'm very excited about the challenge of this upcoming season. We have stressed the importance of hard work, commitment, leadership and passion throughout the offseason," said Jill DeVries, who is in her 12th season as head coach. "Our commitment to developing individual players has helped us grow and get better every day. Our team has worked extremely hard during the summer and we're anxious to see how everything comes together. We have six returning players who are ready for the challenge of our DAC and non-conference schedule. This group has a winner's mentality that is contagious and pushes the team to achieve goals and set high standards on and off the court. And, we are very excited about our newcomers."

Leading the way for the Vikings are seniors Amanda Brown (12.3 ppg) and Caitlyn Wojahn (11.9 ppg) who finished last season as the team's second and third leading scorers respectively. Brown, along with senior Jacklyn Mitchell (3.8ppg) ranked second on the team averaging 4.7 rebounds each in 2010. Wojahn led the Vikings dishing out 108 assists.

Senior guard Mandy Johnson returns as another threat offensively. Johnson poured in 234 points in 30 games (7.8 ppg). The fifth senior on the roster for the Vikings, Jenna Vrchota, saw action in all 30 games averaging 3.5 points in just under 12 minutes per game.

The team also welcomes back sophomore Courtney Titus. Titus demonstrated exceptional defensive prowess early in the season before having to undergo heart surgery mid-season. In 20 games, Titus averaged 3.9 points and 4.3 rebounds in 25 minutes per game. Titus will be instrumental in leading the younger Viking players this season.

The Viking's junior class is made up of three junior college transfers. All three have the advantage of possessing valuable playing experience at the collegiate level and hope to build on that experience and leave their own mark in the VCSU women's basketball program.

Junior guard Kristin Bearstail led United Tribes Technical College to a 20-12 record in 2010 while averaging 22.6 points, 4.1 boards, 5.1 assists, and 3.4 steals per game for the Thunderbirds. Junior forward Mandi Bindas played at Lake Region State College in 2010 averaging 14 points and 6.6 rebounds per game for the Lady Royals. She shot 48.8% from the field hitting on 41.7% (10/24) of her three point attempts. Junior point guard Lexi Daniels led Itasca Community College to a 20-7 record in 2010 while averaging 16.5 points, 4.5 assists, and 3.2 steals while shooting 37% from beyond the three point line her sophomore season.

DeVries adds, "We have solid experience and talent in our senior, junior and sophomore classes. In addition, we have six freshmen that will fight for playing time. Of course, they will have to adjust to the college women's basketball speed and strength, but they are eager to put on the Viking uniform and contribute in any way they can."

The Vikings welcome a bevy of young talent to this year's squad. The team features five true freshmen and one redshirt freshman. These youthful players will be forced to adjust quickly to the tempo of the college game and will play a vital role in the success of this season.

North Dakota products Laura Lies, 5'9" forward from New Rockford, and Summer Romine, 5'9" guard from Mohall, join Shelby Wetzel, 5'4" guard from New Rockford in the Viking freshmen class. Minnesota products, Liza Torgerson, 5'8" guard from Elbow Lake, and Tess Rahto, 5'11" forward from Brainerd, along with Brittany Lehner, 5'10" forward

from Watertown, South Dakota, round out the incoming players.

"Our theme this season is "Good to Great!"
We strive to work hard both on the court and in the classroom to be the best we can possibly be," DeVries added. "I believe there is a buzz around VCSU women's basketball and I don't think this group will be satisfied with anything less than a trip to the national tournament come March. We will continue to work hard and get better every day so that we can win one of the toughest NAIA conferences in the country!"

## Men's Basketball Preview: Aiming for the National Tournament

In 2009-10, the Vikings felt that their season ended a little prematurely after finishing as co-champs in regular season conference play and then getting upset in the semifinals of the conference tournament. The success of the Vikings during the 2010-11 season will rely on a combination of a core group of experienced players with some exciting new talent in the program. VCSU has built a reputation under the direction of head coach Jeff Kaminsky of being one of the best defensive programs in the country. That should continue again this season as the Vikings have a goal of nothing less than the national tournament.

Continuity from the 2009-10 championship team will be provided by a core of returning seniors that played an important role last year and can be counted on to make this year exciting as well.

Among the seniors returning is Calvin Kraft, the 6'3" guard from Casselton, ND. Calvin is one of the premier shooters in the country (6th) and was named 2nd Team All-Conference in 09-10. Calvin led the team in scoring (12.5 ppg) and 3-pointers (97). He is already the all-time 3-point shooter in school history with 225. Expect Calvin to have another outstanding year leading the Vikings.

Also returning is senior Tyler Macomber, the 6'4" forward from Elk River, MN. Tyler has started for the Vikings for the past three years and was named 2nd Team All-Conference in 07-08. He averaged 9.6 points and 6.1 rebounds per game in 09-10. Expect Tyler to build on his previous success and experience, and become one of the elite players in the conference.

Mike York, the 5'11" senior guard from Burnsville, MN, will rejoin the Vikings after redshirting and playing football in 2009-10. His defensive pressure on the ball has had a major impact on the success of VCSU. He was named the Dakota Athletic Conference Defensive Player of the Year back in 07-08.

Mark Klingberg, the 6'9" center from Prior Lake, MN, is also returning for his senior year. Mark averaged 9.1 ppg and 4.5 rpg, and led the Vikings in field goal percentage making 55% of his shot attempts. The most talented inside player on the roster, expect Mark to play a major role in 2010-11.

Five other veterans bring further continuity and experience to the 2010-11 team, plus nine new prospects are sure to bring excitement and depth. Look for the Vikings to go for the Championship again this year!

# Osmon Fieldhouse Adds Offices

## Viking Women's Basketball, Volleyball Teams Recognized for Academic Achievement

Two women's athletic teams at VCSU were recently recognized for academic excellence during the 2009-2010 academic year by their respective national associations.

The Women's Basketball Coaches Association (WBCA) named the Viking Women's Basketball team to the 2009-10 Academic Top 25 Team Honor Roll. This award, given to teams in the NAIA and NCAA, and Junior College/Community Colleges, awards teams throughout the nation that carry the highest grade point averages (GPA) for the entire season. The GPA of VCSU's Women's Basketball team was 3.688 on a 4.0 scale, second nationally in the NAIA and third in the entire WBCA.

In addition, the American Volleyball Coaches Association (AVCA)

announced recently that the Viking Volleyball team was recognized with the AVCA Team Academic Award for the 2009-2010 season. The award honors collegiate and high school volleyball teams that displayed excellence in the classroom during the school year by maintaining at least a 3.30 cumulative team grade-point average on a 4.0 scale.

We recruit young people that epitomize the term student-athlete and they take seriously the responsibility for their academic effort. ## **Copper Street Brass Quintet featured** at Ployhar Festival

The 8th Annual James D. Ployhar Honor Band Festival was held on VCSU campus October 8-9, 2010. 52 student musicians from 12 high schools ranging from Amidon, ND to Ada, MN rehearsed for two days to put together a wonderful concert in honor of the VCSU Music Department's honored alumnus.

After graduating from VCSU in 1949, Ployhar went on to a distinguished career in the music industry as a prolific composer, arranger, and promoter of music education, gaining international renown with over 800 published compositions and arrangements. He was given the VCSU Distinguished Alumnus award in 1977 and was inducted into the Music Hall of Fame in 2007.

This year's festival featured the Copper Street Brass Quintet as ensemble-inresidence. A professional brass quintet based in Minneapolis, the CSBQ worked with the Honor Band students in sectionals and masterclasses, and performed with them on the final concert. The concert consisted of Ployhar's arrangements of "Praise to the Lord" and "When Love is Kind," along with Eric Whitacre's striking "Lux Arumque" and the "Marche Militaire" by Tchaikovsky. The featured piece on the performance was James Curnow's Five Concord Diversions written for solo brass quintet and wind ensemble. Led by VCSU's Dr. James Adams, the Honor Band students, representing

## **VCSU Music Hall of Fame Banquet Honors Two Individuals**

The 2010 VCSU Music Hall of Fame Banquet was held on September 18 at the Valley City Town & Country Club. The event has become a popular means of recognizing outstanding alumni and past faculty. This year, two individuals were honored.

Ward Thomas (Tom) Stine received a B.S. in Music Education from VCSU in 1965 and was honored posthumously. He taught band and choir at Kathryn, ND and Larimore, ND before moving to Modesto, CA in 1969. He taught band and orchestra for Mark Twain Jr. High School, where he was the Music Department chair, and prepared the music curriculum for band, orchestra, and choir. Tom was the originating chair and band director of the Beyer High School Music Department. He collaborated on writing the school hymn and fight song for Beyer High School, both of which are still used today. He also served as the conductor of the

summer concert band in the park for Stanislaus County (MoBand). During his career, Tom conducted hundreds of concerts, including concerts given by the Valley City Community Band. He recorded one album as a member of a rock band in the 60s called the NuBeats.

Tom served on the Valley City Chamber of Commerce and sang in church choirs, often assisting the directors in their absence. One of his final contributions to VCSU was to serve on the Friends of Music Board to assist the VCSU Department of Music move forward with fundraising and marketing.

Dr. Loren R. Waa was the band director at VCSU from 1964 to 1970.

and has had a long and distinguished academic career. He received his Bachelor of Music degree from Concordia College and went on to receive a Masters in Music Education and a Doctor of Education in Music Education, both from the University of Illinois. He has taught band, chorus, and general music in the public schools, and brass lessons and band at the collegiate level, including at Valley City State University. While at VCSU, Waa was an extremely popular band director

whose students still remember him fondly. After leaving VCSU he went on to serve as the undergraduate music education coordinator at the University of Louisville and the founder and director of the University of Louisville's Kentuckiana Music

Institute. Although Waa's background is in band, he has held numerous church choir positions and continues to be active in his current church music program. Another distinction held by Waa is the fact that he has served as president of the North Dakota and Kentucky Music Educators Associations. Waa is the recipient of a number of awards including the Albert Austin Harding Award from the University of Illinois, The Kentucky Music Educators Association Twelfth District College/University Teacher of the Year, the Kentucky Music Educators Association State College/University Teacher of the Year, the University of Louisville Award for Administrative Excellence, the Kentucky Music Educators Association Distinguished Service Award, and an appointment as a Kentucky Colonel by the governor of Kentucky.

## McLean, Christie Exhibit at VCSU Gallery

Two alumni from the VCSU Art Department, Molly McLain '05 and Jessica Christy '07, continue to make creating art central to their daily lives.

Jessica's work was included in the Master of Fine Arts Graduate Student exhibition which opened the VCSU Gallery this fall. Molly has a solo exhibition in the VCSU Art Gallery November 1-24, and held a reception on November 4.

Molly grew up on the prairie, connected to the land. Her art centers on environmentalism and that connection. Her current work centers

## Official VCSU License Plates – Show your Viking Pride!

North Dakota residents and VCSU Viking fans can now order personal Valley City State University license plates for their vehicles.

The VCSU Foundation and the North Dakota Department of Transportation are pleased to provide an opportunity to show your Valley City State University Viking Pride every day as you drive your vehicle around the state and across the country. By supporting this 'pride promotion,' you also directly support Valley City State University and its V-500 scholarship program.

It's easy!

Available to all North Dakota vehicles. Anyone who has a registered North Dakota vehicle can secure a plate. You do not need to be a VCSU alumnus or student.

To purchase the VCSU plate, the cost is \$25. The State will return \$15 of this fee to the University. After the initial purchase, you will be assessed an annual VCSU license plate fee of \$25, plus your regular tag renewal fees on your normal anniversary registration statement.

The standard VCSU plate will have five alpha/numeric characters numbered from 36000-36999. You can secure a vanity plate for an additional \$25 fee.


# Tom Stine Scholarship Fund Established


