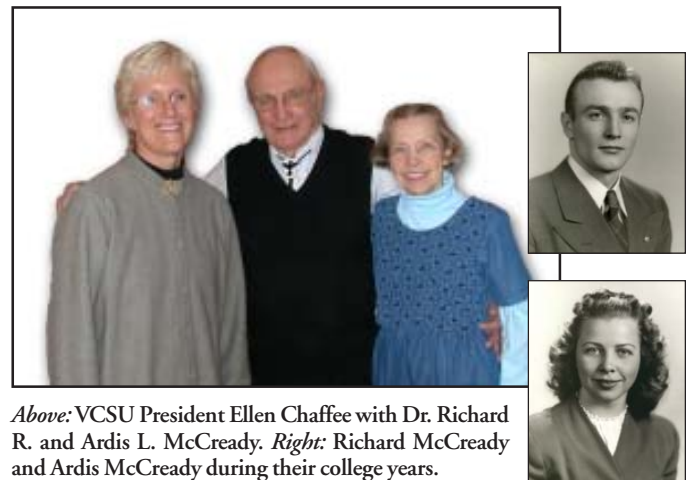

Dr. Richard R. and Ardis L. McCready of Sun City West, Arizona, announce the establishment of the McCready Scholars Endowment at Valley City State University. The endowment will provide scholarships for outstanding students. Each McCready Scholar will receive full funding for tuition, fees, books,

supplies, room and board. The scholarship will be re-awarded annually for a maximum of four years of support to Scholars who maintain a 3.5 grade point average or above and make yearly progress toward their degree. Students in any academic discipline may qualify as McCready Scholars.

The McCreadys have established the fund with a current gift of stocks and a binding pledge from their estate, estimated to be in excess of \$1,000,000. The first scholarship will be awarded when the interest on the fund is enough to support a student for four years of college study.

Dr. Richard R. McCready was a member of the VCSU class of 1949. He served many years as a Professor of Quantitative Systems at

Arizona State University, in Tempe, Arizona. In 1982, the VCSU Alumni Association presented Dr. McCready with the Distinguished Alumni Award. Ardis McCready was a member of the VCSU class of 1947 and served many years as a legal secretary and a public school teacher.

According to Dr. Ellen Chaffee, president of Valley City State University, "The McCready Scholars Endowment represents the largest gift in the history of Valley City State, and a major commitment to the university and its students. The McCreadys are making a lasting impact on attracting outstanding students to Valley City State University. We are extremely thankful for this wonderful gift."

Former NIH cancer researcher finds a home at VCSU

Can a Dutch Ph.D. toxicologist researcher from the NIH's National Cancer Institute in Bethesda, MD, find happiness teaching science at a small university on the plains of North Dakota? In August 2002, Hilde van Gijssel (pronounced van-HI-suhl), a researcher from Leek, The Netherlands, traded her NIH job for a teaching position at Valley City State University. Of her life in Valley City, ND, she says, "It's a completely new world. But even if they give me a million bucks, I'm not going back. There's no way." After one year at VCSU, van Gijssel was not only honored as the university's top teacher of 2003, but also raised student interest in science and helped lighten the science faculty's teaching load, providing them with more time to pursue their research. In addition, she's developing a laboratory to pursue research in toxicology, her primary interest. The new lab will enable van Gijssel to collaborate with ongoing research at VCSU, as well as pursue collaborations with the state's research universities at NDSU and UND. "Students are talking about research because it's much more visible now," van Gijssel says. "They're talking to me about working in the lab. They're coming to me and asking questions about what they have to do to get into research." North Dakota BRIN provided the initial funding that enabled VCSU to hire van Gijssel for a tenure-track faculty position as the first step toward creating a health sciences program. Andre DeLorme, VCSU associate professor of biology, said the idea of hiring someone to fill a biomedical research position at the university began at a meeting to discuss how North Dakota's baccalaureate schools could fit into BRIN, a program aimed at

increasing the state's biomedical research capacity. "To be honest, Valley City State didn't really have a n y biomedical research," he recalled. "But then we started brainstorming and it came to us: We could use BRIN funding to get a new position. We could work to get somebody in biomedical research." DeLorme and others at VCSU were hopeful when van Gijssel applied for the job and delighted when she accepted the offer. "There is no way we could have attracted such a candidate without BRIN support," says Les Wong, VCSU vice president for academic affairs. Recalling her initial impression of North Dakota, van Gijssel notes, "You drive over I-94, it's flat, then you have the valley and – surprise! There's a university with up-to-date technology in a state that's known throughout the country as being conservative and rural. A lot of scientists and people in academia talk about the east coast and the west coast as if there's hardly anything in the middle," van Gijssel says. "It's not true. We have a good place here. We have a role in preparing students and showing them something about the world." In less than a year, the addition of van Gijssel is benefiting VCSU by helping to generate potential biomedical researchers for North Dakota. She says that local high school students are expressing interest in her classes. The enrollment for her summer microbiology class swelled from 14 to 36 when students from the surrounding region enrolled. Through BRIN, van

Gijssel last year initiated a program that enables students to present their research statewide over the Interactive Video Network (IVN). Students and teachers in videoconference rooms on the network can watch the presentations and participate in discussions about the research. "For the first one, we started with 17 people at two sites," she says. "The second one was 20 people at four sites. The third one had 26 people over five sites. The benefit of that is that students come to me and say, 'Can we do that, too?'" With the addition of van Gijssel, VCSU hopes to add courses in cell biology and possibly toxicology. The university is moving toward its goal of developing an undergraduate program that prepares students for careers in biomedical research and provides a pre-professional focus for medical school and studies in pharmacy, dentistry, optometry and nursing. When her lab is complete,

van Gijssel will use her toxicology expertise to collaborate with DeLorme, who studies how water quality affects macro invertebrates. "There are a lot of controversial water projects in North Dakota and there's a desperate need for data about what happens when water flow is changed or what happens when levels of sulfate or mercury increase," she says. The opportunity to teach and conduct research attracted van Gijssel to VCSU. She has no regrets about her decision. "Students suddenly realize that chemistry is everywhere around them and that it's something that's always been out there," she says. "It's everything. It's life and it's fascinating. This is what I was born to do. I finally figured it out."

Student soldiers to be first to earn college credits in Iraq

CAMP VIRGINIA, Kuwait – College classes don't typically start in late February, but these aren't your typical college classes.

Students walk half a mile across desert terrain to get to class. School uniforms aren't necessary, but most students are dressed the same nonetheless – tan desert camouflage uniforms, boots and a neck gaiter to help guard against any sandstorm that may blow in on the way to or from class.

The students are soldiers first, learning in their off-duty time in Camp Virginia, Kuwait. They're deployed with North Dakota's 141st Engineer Combat Battalion, which will move north into Iraq within the next month. The soldiers are part of a major first – never before have students been able to earn college credits for classes taken in Iraq.

"Many of the soldiers in the 141st are college students currently enrolled in North Dakota universities and these classes allow them the opportunity to continue their education while serving their country," says Sgt. Joan Aus. There are more than 55 students enrolled in her classes.

Aus, a professor at Valley City State University in North Dakota, who is serving as a logistic loadmaster for the battalion, is the instructor. Her classes have a somewhat different tone in this desert environment. She draws connections to military life and situations while she instructs. Yet, she reminds her students that this is college, not the Army.

"When we're in here, I'm not Sgt. Aus, I'm Professor Aus," she tells her students on the first day of speech class.

It's the first college course some of the soldiers have taken.

"I think it's nice to be able to keep busy, and I'm excited to start college, even though it is in the desert," said Pfc. Ashley Aune, 19, of Mayville.

She's enrolled in Speech and Composition I. While she's nervous about public speaking, she's at ease with the small class size and her fellow soldiers.

"Speech is one of the best classes for this environment because it's really low-tech, and the emphasis is on the student, rather than the surroundings," Aus says.

The lower tech the better in this field environment. Power is sporadic and the accommodations are often coated in sand. There are other things to overcome, as well. For instance, the textbooks for the speech class were in Aus' footlocker

on a ship still a few days from arriving in a Kuwaiti port when her class started.

Minor obstacles are easily overcome with the professor's knowledge and the students' enthusiasm, however.

Students attend class twice a week for three hours. The students will earn three credits per class, which will be applied to the degree they're pursuing at their respective

colleges. For students who have not yet begun college, they will be granted credits as itinerant students and be able to apply them to their degrees once they are accepted to a college.

Once the current semester wraps up at the end of May, students will be able to take Composition II and Introduction to Literature during the battalion's second semester.

On the brink: ND music to his ears

Brad Lambrecht expects to leave North Dakota, but he promises he'll be back.

And when he does return, it'll be to teach music.

Lambrecht, 21, will graduate in spring 2005 from Valley City State University with a degree that



will enable him to teach in any grade through 12th. His zeal to teach—and a list of activities that's exhausting just to read—made VCSU's music department nominate Lambrecht as a young person on the brink of success.

As a musician, his main instrument is French horn. He also plays flute, trumpet, handbells, organ, piano, clarinet, flute, sax, trombone, tuba and cello, although he admits to playing all those with varying degrees of proficiency.

While at VCSU, he's been a member of the concert choir,

concert band, University Singers, percussion ensemble, jazz ensemble, brass ensemble, horn quartet, handbell ensemble, woodwind quintet and recorder ensemble. He is a two-time member of the North Dakota Intercollegiate Honor Band and plays with the Sheyenne Brass Quintet.

As a French horn player, Lambrecht recently won the Music Teachers National Associating recital competition in

Bismarck and will advance to this spring's regional competition in Colorado.

He is a member of VCSU's Music Students Advisory Council and Collegiate Music Educators National Conference. He gives tours to prospective VCSU students, heads the school's chapter of Young Democrats and is involved in collegiate theater.

And in his spare time, he directs the children's choir at a Valley City church and works with Valley City's Open Door program, which provides support for the developmentally disabled.

He does all that with a broad smile, infectious enthusiasm and a passion for his dream of becoming a high school music educator.

“A dream would probably be teaching at a smaller college,” he said. “But I'll shoot for the stars and if I hit the moon—hey, I got somewhere.”

VCSU music professor Sigurd Johnson said Lambrecht has picked the right dream.

“He has a very winning personality,” Johnson said. “He is a positive person. ... I think he'll make an excellent teacher, the type of teacher who'll build up and not cut down.”

While he said he may attend graduate school elsewhere, and understands the attractions of living in larger urban areas, Lambrecht fully intends to return to North Dakota for a career as a small-town, high-school music teacher. Small-town North Dakota students deserve that education as much as anybody, he said.

In tough financial times, music education often is regarded as a frill, Lambrecht said. “It's considered something extra, (but) I believe it's something that should be studied above all else,” he said.

“The arts teach us to understand who we are. They teach us to become sensitive to the aesthetic world around us. Me being able to teach that, it's what I can give to this world.”

Uncovering History at the Historic President's House

The historic President's House of VCSU was built near the turn of the century. Now used as a Guest Inn for visitors to the Valley City area, the home is available for use by the day, night or week. The home accommodates small meetings, family gatherings, and parties. The Guest Inn is available by single room or the entire house, which sleeps a maximum of nine, in a family atmosphere. Consider staying at the home on your next visit to Valley City. Recently the home's exterior has been returned to its historic paint colors and paint scheme.

The President's House Preservation Society has begun research to develop an interior restoration plan for the historic home. Research has uncovered original wallpaper designs, decorative moldings, and other items to assist in the planning. However, some missing decorative elements have left very little trace of what they looked like historically. For example, there are indications that several room entrances contained decorative interior, wooden, fretwork or “gingerbread.” But, with no interior photos

depicting the designs, the group can only make educated guesses as to what the fretwork looked like originally. “It is like turning back the pages of time,” says Becky Heise, co-chair of the Society, “We are really hoping someone with photos or memories of the home's interior will assist us.”

The interior restoration plan hopes to return the house to its early 1900s grandeur. There are other questions that remain unanswered, and the group is seeking historic photos, trying to locate original furnishings, and hoping to speak with former residents/visitors of the home to gather information to assist with the development of the interior restoration plan over the next few weeks.

Lamonte "Monte" Johnson, Registrar at Valley City State University, has aided the school in numerous ways. Starting with being an admission counselor and assistant basketball coach, where he eventually took over the reigns for two years, to director of admissions to finally having the position of registrar, he has climbed the ladder with each job he's had.

Monte started at the University in 1978 as an admission counselor and assistant basketball coach under Darrell Anderson. He assisted for 10 years until he was the interim basketball coach from 1989 to 1991. While coaching, he taught in the Physical Education department. During his time in the admission office, he moved from his position of admission counselor to director of admissions. Then in 1999 he took over the office of the Registrar.

Working in admissions and records has allowed Johnson to see different trends the college has gone through in recruiting new students. "We've changed in several ways. There's been a big development in technology and with that there are different ways to deliver courses in different modes," said Johnson. Johnson acknowledged that as the college expands its horizons to reach further, so do other schools. "We can't afford to miss a beat; it's a tough market out there but we just keep learning along the way."

Before Johnson came to VCSU to work, he grew up in the Nome/Fingal area and graduated from Fingal High School in 1970. Once he graduated, he said that he was looking for a local college and VCSU fit the mold. It didn't hurt that his older brothers and sisters went there as well. From there he went to Hope where he taught English in grades 7-12. He was also the head basketball and track coach. While teaching there Johnson said the teaching methods he learned at VCSU were "very valuable." He noted outstanding teachers he had that more than helped him along the way. "Annie Gunderson in English and Dr. Larry Grooters in physical education were excellent role models. They were great teachers."

Monte and his wife Pat have three children, Heather, 30; Josh, 27; and Justin, 24. Pat is the Principal of the Maple Valley Elementary and she teaches there as well.

Charlene Stenson '83



Former Valley City State University women's basketball standout Charlene Stenson has come back to the University to work as an Admissions Counselor. After substitute teaching in the Valley City area for two years, Stenson took the job in the fall of 1999. "My husband was hired by a local phone company here and I saw there was an opening so I decided to apply," said Stenson.

Many may remember Stenson's skills on the basketball court, she was a four year starter and a three time all conference selection for the Vikings. She came to Valley City from Cooperstown after graduating from High School in the spring of 1979. After being recruited by Coach Linda Roberts, Stenson enrolled in the fall '79 majoring in physical education and recreation. Stenson said she got into the starting line up about half way through her freshman year and started until the end of her senior season. Along the way her team won the conference championship in 1980 and 1981.

Stenson also played a year on the softball team her junior year and ran track her senior year. "I really wish that I had been in track for more than one year. It was a great experience," added Stenson. All her hard work paid off, Stenson was inducted into the Valley City State University Basketball Hall of Fame in 1995 and into the Softball Hall of Fame in 1997.

After graduating in the spring of '83 she got married to her husband Dean and moved to Fargo where she worked at a bank; while working she also coached basketball at Ben Franklin Middle School. Then Stenson went back to college and got her Elementary Education degree from Moorhead State University in 1986. Vikings on the Move

1920's
