Students Give VCSU an

We got a fantastic holiday present from our students in the form of results from a survey they completed last fall. The study showed that students at Valley City State University want the same things from their university as students at other four-year colleges. The difference is that at VCSU they are more likely to get what they want.

The North Dakota University System selected the Noel-Levitz Student Satisfaction Inventory as the best available tool to assess student satisfaction as part of a legislatively mandated accountability system. All NDUS campuses administered the survey in fall 2002. Individual questions are clustered to form 11 scales: academic advising, campus climate, campus life, campus support services, concern for the individual, instructional effectiveness, recruitment and financial aid, registration effectiveness, safety and security, service excellence, and student centeredness.

Nearly 400 VCSU students completed the 115- item questionnaire to measure their satisfaction with the university on these 11 key services. On all 11 scales, students at VCSU were significantly more satisfied than the average for students at other four-year colleges both in the state and nationwide.

This has to be our crowning glory. In the last year we have won several state and national awards and received the official seal of approval from three accrediting agencies. But at the end of the day, what really matters is what students think. This strong positive affirmation from the students of VCSU validates all the other honors.

Highest Employee Satisfaction – And Aiming Higher

Faculty and staff rated Valley City State University on eight key quality dimensions last fall, and they rated the university higher than the national average for four-year institutions on all eight, and higher than the NDUS average for four-year institutions on all except for one tie score. The testing company stated in its final report that, "VCSU levels of satisfaction (83%) are higher than the overall NDUS average (75% combined satisfied and very satisfied). VCSU respondent overall impression of quality ratings (84%) are above the average NDUS (75% combined excellent or good). VCSU has the highest rating of the four year campuses for both of these items. These high ratings indicate that a favorable organizational climate is perceived by *Satisfaction*, continued on page 12

"I try to ensure that campus personnel are the first to know things that may affect them. And I hate rumors. And I don't like repeating myself."

So began my email message to all faculty and staff on October 22, 2002. Since then, I have had a wonderful opportunity to learn from and with others by being totally candid about my health situation. Of course, it's pointless to try to keep a secret in North Dakota, anyway!

To summarize briefly, I had breast cancer, with a mastectomy

in November, many tests in December, and chemotherapy from December 27 to March 3, 2003. The cancer was stage II with one lymph node involved and my doctor's term for my prognosis is "just excellent."

Larry Robinson asked me to write to you about this because many of our readers are too far away to have known about it from local media or discussion. We deeply value your commitment to Valley City State University, and a presidential illness is certainly relevant to the university itself. Its relevance is rapidly fading, however. I am pleased to report that I probably missed less than three weeks of work, thanks to miraculous advances in medical care. And leadership is widespread at VCSU. Everyone throughout the university ensures that we continue our aggressive pursuit of quality, innovation, and service. Proof that their spectacular efforts produce world-class results are in recent faculty, staff, and student satisfaction surveys, posted online at *http://satisfaction.vcsu.edu*.

On a personal note...

Until October of 2002, I took my health for granted, and I had every reason to do so. I had stockpiled over seven months of unused sick leave, I had had two outpatient and no inpatient surgeries in my entire life, and the last time I was hospitalized was thirty years ago for pneumonia.

A diagnosis of cancer changes everything. It shook my self-concept as a healthy person who takes care of herself, for starters. For a while, I would question what I ate or drank, whether to use the microwave oven, medications I had taken or not taken – everything.

Given my position as president, it also challenged my guidelines for personal privacy. In a different job, I would not have sent an email announcement to 265 people, published a couple of newspaper articles, or started a web site dealing with my health. As president, though, I felt that university personnel and friends had a right to know. Opting for openness has enabled people, including many who were strangers to me before, to connect with me in new ways. Some offer comforting stories, some seem to take some comfort that they are not alone, and all have made precious contributions to my wellness.

Most of all, I am keenly aware, now, that I do not have forever to do what is important to me. I need to manage my time as well as my money ("better" would be good for both!).

Perhaps you can understand that first I needed to clearly define what is important to me. We so often get caught up in busy activities that such reflections are hard to come by. In truth, I am still working on that definition. The fact that our only daughter will be having our first grandchildren (twins!) in June certainly tops the priority list.

Assuming that family and faith top the list, identifying other priorities requires careful thought. I realize now that the priority theme of my professional life has been to help quality organizations achieve worthy goals, and that priority remains important to me.

I have concluded that my time at VCSU is an excellent investment that is paying exceptional dividends. VCSU has earned multiple national, state, and local awards. Best of all, students love it here. Your Viking pride is more than justified.

Innovative Teachers Program Grant Awarded

With support of an Innovative Teachers Program grant from Microsoft Corporation and the American Association of Colleges for Teacher Education (AACTE), Valley City State University's Division of Education, Psychology and Technology now will be able to strengthen their collaboration with area schools to improve learning through effective use of technology in the classroom.

The Division of Education, Psychology, and Technology is currently collaborating with Valley City Public Schools, Saint Catherine's Elementary School, Valley City; and Madison Elementary School, Fargo through the U.S. Department of Education Preparing Tomorrow's Teachers to use Technology (PT3) grant program. The grant provides \$430,000 of a \$1,000,000 effort to prepare future teachers to improve education with the power of new technologies for learning. The Innovative Teachers Program aims to build an online community of educators who work collaboratively to enhance teacher education and student learning through the use of technology. Together the two grants provide training for the teachers on the effective use of technology and VCSU student technology consultants to help implement the technology.

Grant recipients are provided with a number of tools to help them design, implement, and foster their Innovative Teachers Program, including:

- 250 Software licenses for all current Microsoft® desktop applications and operating systems worth half a million dollars
- · Access to professionally designed and tested online softwaresupport materials
- Online collaboration and community-building tools for designing and sharing best practice models

Grant funding will bridge the divide between pre- and in-service teachers to assist them in using technology in their classrooms with the goal of developing high-quality teachers now and in the future. The Division of Education, Psychology, and Technology will assist their partner school districts in using technology in their classrooms with the goal of developing high-quality, technology-rich lessons that can be shared through the Innovative Teachers Program online community.

Valley City State University is one among 56 other universities in the nation to receive this innovative technology grant.

Picking Up the Pieces

After the funeral, the two surviving children went to work sorting through the papers of their deceased father, trying to get a handle on his financial situation. They discovered three things:

- 1. Their dad, a retired human services worker, had accumulated remarkable wealth through conservative investments and frugal living;
- 2. Their dad had been generously supporting several charitable organizations.
- 3. Their dad had left behind no will or other instructions to guide them in the distribution of his estate.

Faced with this situations, the children decided to give part of whatever portion of his estate they might receive to those organizations their father had supported during his life. They had to make assumptions about which organizations to help, how much he would have wanted to give an in what proportions. Not knowing his wishes made a tough time tougher.

This is just one of several thorny issues the surviving family faces when a loved one dies without a will. In the midst of sorrow and time pressures, difficult decisions must be made.

How much better it would have been had the father taken the time to create a will.

Indeed, having an up-to-date and valid will is one of the greatest gifts any father or mother can give family members.

Valley City State University Your Choice Investment in 2003

By the time you read this column, the North Dakota legislature will either have adjourned or it will be very close to ending it's work for 2003. For those of you who don't know, in addition to serving as Director of University Advancement at VCSU, I have served in the North Dakota Senate since 1988 representing District 24. Every year the North Dakota legislature goes into session for three and one half months. The session convenes in early January and adjourns in early to mid April. My committee assignment in the legislature is the Appropriations Committee. I have been able to be involved in the legislative process do to the tremendous support that I have received from President Chaffee, the office staff, our boards, and the entire university community.

A few days ago, President Ellen Chaffee and Bill Ament, Comptroller appeared before the Senate Appropriations Committee and presented the budget for VCSU for the 2003-2005 biennium. The general fund budget for VCSU for this two year time period approaches some 12 million dollars. Needless to say, Dr. Chaffee and Mr. Ament did an outstanding job with the budget presentation. Unfortunately, North Dakota economy is struggling, much like the economy in nearly every other state. The pressure on the state's general fund is real. As a result, the dollars for the North Dakota University System and VCSU are impacted accordingly.

The budget challenges that VCSU is facing parallel those challenges that other colleges and universities are facing across the nation. Issues such as deferred maintenance, rising utility costs, double digit increases in employee health care, technology, and extra ordinary repairs to facilities are placing significant demands on budgets. In addition, faculty and staff salaries lag far behind the regional averages. Our ability to retain and recruit quality faculty and staff hinges upon our ability to remain competitive with salaries and fringe benefits.

As a result of these challenges and the shortage of general fund dollars, colleges and universities across the country are turning to tuition increases to offset some of the rising costs. VCSU is no exception. The colleges and universities in North Dakota are considering double digit increases in tuition for both years of the biennium to generate additional revenue. At VCSU, those increases could range from 14 -16%. Although these increases are significant, our tuition levels will remain competitive with the region because tuition increases are expected across the country.

The pending tuition increases place new meaning and importance on the availability of scholarship dollars. With your support, VCSU has done well over the years in this area. Unfortunately, the advent of double digit tuition increases reminds us that we must do better. Our ability to continue to attract quality students is directly related to the availability of scholarship dollars. We simply must be successful in this endeavor.

We are in the midst of our annually V-500 Scholarship Program membership drive and our annual Alumni Association Phone-a-thon. Many of you have supported these important programs in the past. We thank you for that support and trust that you will do so again this year. If you have not contributed to these important programs previously, we would ask that you give serious consideration to doing so this year. I know there have been a number of opportunities for me to express my pride and satisfaction with VCSU, but nothing ever stuck out in my mind. Every experience I have had has been wonderful. I love the faculty, the staff, the students, the atmosphere, and the education I have received here at VCSU. Where would I start when asked, "What do you love about VCSU?" This is my fifth year and I graduate this spring. I have given tours, worked with the summer orientation program, and learning to live...each one giving me the opportunity to tell everyone what a great school we have allowing me to draw people into VCSU and work at keeping them here. I have told these people there is nowhere else in the world I would have chosen, but right here in Valley City, N.D.

Finally, in my fifth year, I cannot answer this question without crying - knowing I am about to leave the one place, besides my hometown, that has become my home. My brother has been sent to CO. with the 142nd Engineer Combat Battalion and will soon be sent overseas. There are students from this school that have been sent to various places and I think about them, and my brother, every day. VCSU, this home away from home, is so supportive. I cannot express how I feel when a professor can email me, or meet me in the grocery store, or catch me in the hallway and have the care and concern to ask me how my brother is doing. These people do not know my family. I may have only had one class with them as my professor. But they remember. They recognize my name, my face, and when my brother's name flashes on the TV and he says hello to my family- my professors can walk up to me and say, "How are you, Anita? And how is your brother and family?"

When we had our official send off in Oakes, we asked the soldiers to take care of each other and return safely. The one request that the soldiers had for those at home was "for everyone to take care of their families while they are gone." VCSU has become my family, and I promise to tell my brother you have taken care of me. It means so much to know that so many people care and are there for me in times of need. There are so many people that have said to me, "If you need anything..."those words are very much appreciated.

There is no way to say "thank you" to each and every person on this campus that has supported me and my family, and all of the other students on this campus the way that VCSU does. So - I send this to you, Dr. Chaffee. You can pass this on or spread the word by mouth...but I thank you and this university for the support you give and the family you offer.

Through this process, teachers document their deep knowledge of the subject matter they teach, provide evidence that they know how to teach their subjects to students effectively, and demonstrate their ability to manage and measure student learning.

Glen Schmalz, vice president for student affairs, analyzed the results to determine what areas we need to target in order to increase student satisfaction. At VCSU, as at most universities, students' top priority for improvement is parking. A new lot is scheduled for use by next fall.

Their next priority is financial aid. This is a major issue not only for students but also for the university. Federal and state aid funds are not increasing, while tuition must increase to cover shortfalls in state funding. My recent appointment to serve only VCSU came with a mandate for private fund-raising, and scholarship aid for students is my top priority.

About a decade ago, students often looked first at campus size when they chose VCSU. Times have changed. At the top of their list this year were cost and financial aid, confirming the importance of making college affordable. Academic reputation also outranked size as a drawing card for VCSU this time. This is an very positive result, showing that students recognize and appreciate the university's focus on quality.

Students gave their highest satisfaction ratings to campus safety, reputation in the community, campus maintenance, caring and helpful staff members, knowledgeable faculty, intramural activities, student center, and welcoming atmosphere. These results pay tribute to the exceptional faculty and staff at VCSU.

most survey respondents." VCSU scores were highest on customer focus (highest, at 3.54 on a 5-point scale), measurement and analysis, and strategic quality planning. The lowest scores - but still at or above national and state averages - were for employee training and recognition (lowest, at 3.21), quality assurance (tie with NDUS score), and quality and productivity improvement results. In the mid-range were top management leadership and employee support and empowerment and teamwork. The report noted that there is general support at VCSU for continuous quality improvement and the use of teams. Employee rewards/recognition, communication, and customer service training stand out as areas for further work. The report recommended commending personnel in the following areas for their commitment to providing quality services: switchboard and telephone services; payroll services; business

services; media, audio visual, and technology services; and student activities. The report recommended that the university work on improving communication among departments; research and planning services; marketing, advertising, and public relations; and basic skills and developmental programs. The Executive Team is planning activities throughout spring semester to celebrate the outstanding results of both this survey and the student survey. In addition, the Executive Team welcomes and will be soliciting recommendations on next steps toward even better results in the future. A total of 87 people completed the survey, including 34 support staff, 32 faculty and department chairs, and 21 administrative/professional staff. The complete report is extremely long. 
