

Dr. Gary Thompson, Dean of the VCSU School of Education and Graduate Studies, Dr. Don Mugan, Department Chair of the Technology Education program, and VCSU President Steve Shirley spent two days in Washington, DC in January, 2009. While in Washington they met with Senators Byron Dorgan and Kent Conrad as well as Congressman Earl Pomeroy. They also visited current VCSU student Greg Innocent who is currently an intern in Senator Dorgan's office and will be graduating in May. Drs. Shirley, Thompson, and Mugan met with Patti Curtis, Director of the Washington office of the National Center for Technological Literacy (NCTL). 



## Track & Field, Cross Country Making a Comeback!

Another Major Step in Growth through Athletics

fter a six year hiatus, VCSU is working hard to bring back varsity sports that for generations were cornerstones of VCSU athletics: Track & Field and Cross Country. The decision is creating lots of excitement both on campus

and among our alumni and friends. "I am

very pleased that we are

working on this," said Dr. Steven Shirley, VCSU president. "This is a great way to boost enrollment while adding another element to the student experience at VCSU."

For the last few years, VCSU has

been thinking of athletics as a vehicle to drive growth in enrollment. Dr. Larry Grooters, who recently retired as the Chair of the School of Education and was the Track/ Cross-Country coach from 1963 to 1981, said, "When young people

sity will attract."

If students respond as expected, bringing these sports back will have a noticeable impact on enrollment. Assistant Professor Dave Bass, who served as the coach for 10 years after Dr. Grooters, said,

Both sports have a long history at VCSU. The first season of Viking Men's Track & Field was in 1927 back in the days of the North Dakota Intercollegiate Athletic Conference (NDIAC, which became NDCAC in 1963). The 1930's saw

five conference championships. World War II interrupted the program in 1943, but the program

resumed in 1947. In the 1950's, track saw more glory years with conference championships in 1953, 1954 and 1959. Women's track and cross country began in 1974.

"We are excited about the opportunity to bring back two sports that have impacted so many former student athletes and will have such a positive impact on our campus enrollment and our athletic department. Please help us make this a reality. We need your support. We need your Viking pride!"

## Fundraising Off to a Great Start!

Bringing back Track & Field and Cross Country has one important precondition: raising the funds necessary to get them started. Dr. Shirley said, "Before any new students get to campus, getting these programs started will involve some major expenses such as salary for the coach, equipment, scholarships, travel, and recruiting. These expenses need to be covered without forcing cuts to other programs."

This led the VCSU Advancement Office and Viking Athletics to begin working with alumni on a fundraising drive to cover these costs. The goal is to generate \$150,000 in cash and pledges by this Fall.

The good news is that this drive is off to an amazing start. As this issue of *The Bulletin* goes to press, VCSU has already received pledges that total \$112,500. A big piece of this came from the Valley City/Barnes County Development Corporation, which gave the drive an outstanding start with a pledge of \$60,000. "We are convinced that helping the university grow is entirely consistent with our mission of helping Valley City grow," said Jennifer Feist, Executive Director of the Development Corpo-

ration. "We are just pleased to be in a position to offer this kind of support." Other major donors who have already stepped up include the Jan Ingstad family (\$30,000), Alliance Pipeline (\$15,000), and Dacotah Bank (\$7,500).

That still leaves close to \$40,000 that needs to be raised, no small challenge by any means. To reach this goal, the Office of Advancement and Viking Athletics are enlisting the help of prominent alumni, many of whom (but not all) are alumni of VCSU Track or Cross Country. In all, 12 teams of 18 members have been tasked

with raising \$4,800 each to cover the balance left by the major donors. Pledges are being solicited by mail, and teams are making follow-up calls in April.

Bass is optimistic that this goal is realistic. "Our team captains and their team members are all great supporters of the University, and I know the teams will work hard to reach their goals. They are also a pretty competitive bunch, so I might expect to see them prodding each other to see who can raise the most. It will be fun to watch!"

Both programs were discontinued in 2003 due to budget cuts. "Back then, our administration considered cross country and track too expensive because the squad sizes had dwindled to such a low number of participants. President Shirley understands that aggressive recruiting for cross country and track will help us meet enrollment increase initiatives," said Bass. "When you think of the revenue added from 30 – 60 new students, the return looks pretty good."

The teams should be in good shape as far as facilities go, too. The track at Lokken Field was resurfaced last year, and it includes all the features necessary to host

invitational meets starting in April of each year. Although some believe that an indoor track is a requirement to field a competitive team, Bass disagrees. "Valley City is within an hour of the two best indoor facilities in the area, and our central location means our travel expenses will be lower than many other schools." For Cross Country, Valley City's two golf courses make excellent courses.

If all goes according to plan, VCSU will spend the 2009-2010 year building the program and recruiting the team. The first competition will be the Cross Country season in Fall of 2010 followed by Track & Field in Spring of 2011.

Bass thinks prospective coaches will view this as a great opportunity. "Starting a program from scratch is both a challenge and a tremendous opportunity. For that coach, the door will be wide open for a high level of achievement!"

### Joan Aus Awarded Doctorate in ELL Education

The University of North Dakota recently awarded Joan Aus her doctorate in Education, concentration in ELL (English Language Learners) Education.

Dr. Aus is an Assistant Professor of Education and Director of ELL Education at Valley City State University (VCSU). She has been with VCSU teaching classes in ELL, communication, educational methods and cultural diversity since 1999. In 2004 and 2005, Aus served with the 141st Engineer Combat Battalion in Iraq as a diesel mechanic combat engineer and computer operator, but continued to teach college-level classes in communication to dozens of students in Iraq and Kuwait, and she completed nine semester hours towards her doctorate. She also served with the Air Force during the Persian Gulf War. She earned her B.S. from Black Hills State University and her M.Ed from South Dakota State University.

Dr. Aus developed VCSU's ELL program to be available completely online and to serve both in-service teachers as well as traditional undergraduate students. Enrollment in the program has been growing rapidly and is at an all-time high with roughly 70% of the students residing in North Dakota and the remainder scattered all around the country. Aus is also developing a graduate program in ELL that is planned to be offered in conjunction with VCSU's online Master of Education.

Corporation, 2009).


"I wrote this book to give piano teachers a single source for all the information they need to run the business side of their studio," said Klingenstein. "Teachers who are just getting into the field can use it as a good foundation on what they need to know to run a successful business. Experienced teachers can use it because it has lots of material that is unique in the industry. I also know many teachers who are using it in their classroom as part of their curriculum."

The book covers dozens of business and pedagogy topics, all related in various ways to

the business issues independent piano teachers face. Examples include developing and maintaining professionalism, finances, establishing lessons, image, ethics, studio and national standards, technology, careers in music, funding and advocacy, and many more.

The book includes various unique features that piano teachers will find useful. Each topic includes an in-depth list of references that readers can use to get more information. Another unique feature is an appendix that includes sample documents that music teachers need on a regular basis.

Klingenstein has been with VCSU since 1994 and is the founder and director of the VCSU Community School of the Arts. A music teacher herself for over 40 years, she has also developed a national reputation as an expert in the subject of the business issues involved in teaching music. She has delivered many presentations to local, state and national music organizations, and was a columnist for American Music Teacher magazine, the most widely read publication in the field. Her first book, *A Business Guide for the Music Teacher* (Neil A. Kjos Music Company, San Diego, CA), was pub-



lished in 1987. She holds a Bachelor of Music degree from Syracuse University and a Master of Music degree from the University of Michigan. She is currently working on her Ph.D. in Educational Leadership through the University of North Dakota.◆



## Workshop to Help Teachers Motivate Students through Integrated "STEM"

Faculty members at VCSU are planning to offer a summer workshop for K-12 teachers. The workshop will focus on helping teachers in science, technology, engineering, and mathematics (the STEM subjects) use new and innovative curriculum that dramatically improves student motivation.

Dr. Don Mugan, VCSU professor and chair of VCSU's Department of Technology, said, "The United States is facing a dramatic shortage of graduates in the STEM subjects, and much of this is directly related to traditional K-12 teaching methods that frustrate and discourage students. The curriculum we are presenting at this workshop was designed by nationally-recognized leaders in STEM education, and will give teachers

the tools they need to improve the technological literacy of their students."

The curriculum being presented was developed by the National Center for Technological Literacy (NCTL - a unit of the Museum of Science in Boston) and focuses on helping students apply their math and science knowledge to solve real-world problems. Mugan said, "This approach gets students 'hands-on' with math and science, which gets them more interested and improves comprehension and retention." VCSU has a partnership agreement with the NCTL to increase the number of K-12 educators who can use NCTL materials, and VCSU uses NCTL materials in its own Technology Education coursework.

Workshop leaders will include nationally-rec-

ognized STEM leaders from the NCTL as well as faculty from VCSU's Department of Technology Education. A special keynote address will be delivered by Dr. Yvonne Spicer, NCTL Vice President for Advocacy & Educational Partnerships, at 6:30 pm on Sunday, June 14. On Monday and Tuesday, separate workshops are planned for teachers in elementary, middle and high school grades to meet the varying requirements of their classrooms. The workshop will provide attendees with text and lab materials so that they can begin using workshop concepts right away.

The workshop will be offered June 14 – 16 on the VCSU campus. Continuing education graduate credit is available. For a complete agenda, more information, or to register, visit **teched.vcsu.edu**◆



**Martin "Doc" Kelly Retires** 



## **Bringing Dreams Everywhere She Goes**

How do you follow-up on a career spanning 35 years teaching elementary school children? For Loretta Welk-Jung '64, the answer is to write books that have the potential to touch thousands more.

"I was always a closet writer," said Loretta. She actually wrote many books over her career, but as most were never published, their main use was in her own classrooms. For the two that were published, *Alphabet Apple* (1976) and *Brain Builders!* (1983), Loretta had sold the rights and thousands of copies were printed.

But when an illness forced her to retire from teaching, her thoughts turned to the future grandchildren she may never know. Wishing to leave a legacy of her values to live a well-balanced life, she was inspired to create *Crystalene The Rainbow Snow Girl*.

"Crystalene is not a snowman," said Loretta. "She is a snow girl. And she uses all the colors of the rainbow to teach children about courage, energy, love, hope, freedom, and wisdom." She modeled Crystalene from her German Russian heritage and used the names of her three grandsons as the characters.

In her book, Crystalene, three boy cousins build Crystalene and learn from her about the concepts of courage, energy, love, hope, freedom and wisdom. Each concept is associated with a color of the rainbow: purple is for wisdom... green is for hope... and blue is for freedom... (to keep young boys interested, she lets them know that these colors also represent the Minnesota Vikings, Green Bay Packers, and the Jamestown Blue Jays).

Her first printing was only 100 copies, and Welk-Jung gave away many to grandchildren and family friends. The rest she sold to area schools.

Soon, more grandchildren arrived. So, feeling good about her success and having recovered from her illness, she decided to write a second book. This led to the sequel, *Crystalene*, the *Rainbow Snow Girl*, *Returns*.


As word about Crystalene spread, an article about her appeared in the *Jamestown Sun* and Loretta began receiving requests for school programs that use Crystalene.

Now Crystalene has grown to include even more products including three more books, two music CD's, and even a plush Crystalene doll. In all, 6,000 Crystalene products have been shipped to all 50 states and 10 foreign countries. Loretta has conducted dozens of programs throughout North Dakota and several other states.

With all this activity, she is beginning to have trouble keeping up. "My goal for this year is to explore working with a major publisher who can handle selling Crystalene so I can focus more on my writing and programs.

How will the story of Crystalene end? According to Loretta, "Of course, it will end with a dream!"

## 2008 Football Recap CALHOUN, BEILKE LEAD EXPLOSIVE OFFENSE

The Viking edition of Football for 2008 provided plenty of excitement in both close games and fireworks from the offense. After an exciting 1 point victory over NCAA Division II Minnesota State University Moorhead (30-29), the team finished the season 5-5. Of the five losses, four were by less than a touchdown.

Viking star wideout Chauncey Calhoun was named to the American Football Coaches Association's All-American team and a First Team All-American by the College Fanz Sports Network. Calhoun was the No. 2 receiver in the NAIA with an average of 113.7 yards per game, and added 14 touchdowns. He ended his senior year with the following NAIA national ranks: 2nd in Receptions per Game, 2nd in Receiving Yards per Game, 4th in Scoring per Game, and 15th in All Purpose per Game. He was the only NAIA player chosen for the prestigious Texas vs. the Nation All-Star Game for professional prospects January 31 at the Sun Bowl in El Paso, Texas (shown live on CBS College Sports).

Throwing the ball to Calhoun was senior Quarterback Jason Beilke who had an impact on the NAIA statistics as well. Beilke was 3rd

in Passing Yards per Game and 5th in Total Offense. Beilke, is now the single season and career leader in Passing Attempts and Passing Yards per Game, and the single season leader in Pass Completions, Passing Yards, and Passing Touchdowns. On the career ledger, Beilke ranks 2nd in Completions, Passing Yards and Completion Percentage. He was named 1st Team At Large All Dakota Athletic Conference.

Overall, the Vikings boast the #3 offense and the #4 passing attack in the NAIA.◆



Her senior year helped build upon that mark and she also stacked up numbers finishing 2nd in Games Played and 3rd in Matches Played. With 248 aces, she is one of four players to break the 200 mark, and she is 2nd on the career list (just 1 ace shy of the career mark). She was named DAC "Setter of the Week" numerous times over the past 4 years. Floerke, from Inver Grove Heights, MN, will graduate with a Business Education degree and a minor

in Coaching.

The 2008 edition of the Vikings went from a .500 record to a 9-24 mark with a late season slide.◆



#### 2008 - 2009 Women's and Men's Basketball Recap

The women's basketball team spent the entire season on a mission to prove the pollsters wrong and earn respect. At the end of the year, they had accomplished their mission.

Picked to finish 8th in the preseason poll, the team ended up finishing 4th in the DAC with a conference record of 8-6 and 17-13 overall. Of the team's six conference losses, four were by one possession or in overtime. They won their first round DAC playoff game for the first time since 2003-04, but their season run came to an end with a 67-64 loss in the DAC semifinal at the hands of conference champion Dickinson State.

The team spent 2 weeks in the NAIA top 25 rankings peaking at #19, the highest mark ever for a VCSU women's team. The last time a team was ranked prior to this year was 1993-94 when it spent three weeks in the poll with the highest mark coming at #23.

All-conference recognition came to three Vikings. Sophomore Abby Rittenhouse, a 6'1" center, from Burnsville, MN, was selected for the 2008-09 First Team All-DAC. Rittenhouse averaged 14.1 points and 5.9 rebounds per game. Senior guard Brittany Olson and sophomore guard Amanda Brown were selected for the Third Team All-DAC. Olson, the lone senior

on the roster, averaged 13.6 points and 3.8 rebounds for the season. Brown averaged 10.9 points and 5.4 rebounds.

The men's and women's teams went a combined 4-0 versus Mayville State to retake the President's Cup. It was the first 4-0 sweep of Mayville since the beginning of the Dakota Athletic Conference.

The men's team never quite found their rhythm going 13-16 and finishing tied for 4th place in the conference. They will bid "adieu" to three seniors who helped the team on its best four year run since the glory days of the Osmon era. Ray King, Mike Stowman and Zac Wolf were mainstays of teams that accomplished many things. Last year, they led the team to a #14 NAIA national ranking, the highest ever for a VCSU team. They are the first group of seniors to finish in the top half of the Dakota Athletic Conference each of their four years. Stowman, from Tower City, scored over 1,000 points in his career and is 2nd on the VCSU All-Time list in three point baskets. Wolff, from Park Rapids, MN, finished his career as the all-time leader in blocked shots.◆

#### 2009 Baseball Preview - YOUNG AND HUNGRY

The 2009 Viking baseball team enters the season optimistic under second-year Head Coach Casey Olney. After graduating 10 seniors following the 2008 season, and carrying only one senior on the roster this year, the Vikings are picked to finish sixth in the DAC. With many new faces on the roster, the team is eager to prove itself in the tough conference.

Coach Olney believes this year's Vikings are young and hungry, and he is confident that the team could be a surprise contender down the road. "These guys have a lot to prove. We have a number of players stepping into roles that they have not been in before. It all depends on how ready they are and how well they handle being 'the guy'."

The 2009 Vikings may appear younger than they actually are. With red shirt (RS) junior Josh Standing Elk, RS sophomores lan Jansen and Josh Evans, and transfers Justin Connell, Mike Danielson, and Matt Borgford all probable starters, the team may not be as inexperienced as it first appears.

Offensively the Vikings will be led by RS sophomore Evans and sophomore Tanner Bombenger, who both had above average offensive numbers in 2008. Bombenger hit .267 overall in 2008 which was second among freshmen in the DAC. Evans, who took over as the starter in centerfield half way through the 2008 season, hit .321 with a .429 on base percentage.

Outside Bombenger and Evans, the Vikes do not have a proven commodity with the bat. Cory Arnason, the lone senior, spent last season pitching exclusively, but had 55 at bats two years ago as a sophomore. Olney said "Cory has really committed himself and is in great shape this season. He is stronger and more ready now than he was two years ago to have an impact."

Standing Elk was an all-conference performer two seasons ago at Bismarck State College (BSC) as was Shane Schoeneberg last season. Also joining the Vikes from BSC is junior catcher Justin Connell. "Josh, Shane, and Justin have all played a lot of college baseball and that should serve us well going forward," said Olney. Borgford and Danielson showed promise in the fall and winter. "Matt swings well from the left side and Mike has shown outstanding power and should be the opening day DH. I know both of those guys have the ability to get the job done at the plate," said Olney.

After sitting out last season, RS sophomore Jansen is also penciled into the lineup. "This is lan's third year in the program and I think that this is the year that he is really ready to contribute. When lan was recruited we thought that he could be an outstanding college hitter and this year is his chance to prove us right."

The Vikings have several freshmen who are expected to contribute this season including Garrett Jackson from Gillette, WY, Mark Kerkowich from Neepawa, MB, and Valley City native Preston Jensen. Jackson hit .341 with

5 HR's and 39 RBI's last season for the Gillette Wyoming Legion team which captured the Wyoming state title. Kerkowich hit .416 in the Canada Cup while playing for the Manitoba Provincial youth team. Last Fall, Jensen led all freshmen in the VFL by hitting .386 and hit .439 with 7 HR's this summer for the Valley City legion team. "All three of these guys are ready physically to do the job in college," said Olney.

The 2009 pitching staff looks far different than last year when nine different pitchers started conference games. While many of the faces are relatively new, on paper the overall talent and depth of the staff has been upgraded.

Sophomore Taylor Nelson, second year player Nathan Lutkemeier, Standing Elk, and freshman Valley City native Derek Zitzow are battling for the weekend starter spots. Three

lefties will be competing for two spots in the starting rotation. Dan Maurer, a junior from Linn-Benton CC, Schoeneberg, and Roberto Rodriguez all bring experience to the rotation. Schoeneberg was an all-conference selection at BSC and Rodriguez pitched at the DI JUCO level in the competitive Arizona Community College Athletic Conference (ACCAC).

The closer role will be filled by junior Grant Kragness, who will move from the starting rotation and be called upon to get outs at the end of the game. Olney says "The staff this year is a bit more experienced overall. We have two of the opening day rotation guys from last season moving into the bullpen which I think shows that we have improved from a talent perspective. In baseball it really always comes down to pitching and the depth that teams have on the mound. If we can stay healthy early on, I like what we bring to the table."◆



## 2009 Softball Preview RELOADED FOR NEXT YEAR

Coach Chad Slyter was always reluctant to label the 2008 season as a "rebuilding" year. But with a roster that included 12 freshman it was difficult not to look at it that way. Maybe not accepting that label wore off on the young Viking squad as well.

"I think we kept referring to it as a "reloading" year and not a rebuilding year," said Slyter of the 2008 season. "We knew that we had a talented freshman class to go with the great group of sophomores and juniors, and we knew they were going to compete right away."

The lineup didn't buy into the idea of "rebuilding," either, posting the Vikings third straight 25 win season and a fourth place finish in the DAC tourney in May. The experience gained by the young Vikings in 2008 and another solid recruiting class has given the squad a few reasons to feel optimistic as they prepare for the 2009 season.

The Vikings return their number one pitcher. junior Krystal Hathaway, who pitched a majority of last season with a leg injury and are hopeful she will return to form for the upcoming spring. Hathaway led the pitching staff last year in several categories including Wins (9), Shutouts (3), Innings Pitched (120), Strike Outs (154) and Batting Average Against (.224). "I think the feeling on the team is that we can compete for a championship this spring. We return all of our starters and key reserves from last year and our new players are going to push us to be better so we are all excited," Hathaway said. Also returning on the pitching staff will be junior Karisa Etter. Etter provided valuable innings while Hathaway worked through her injury in the early part of the season, throwing a no-hitter on spring break. They will be joined by freshmen Paige Smith and Jen Shadlock, and both look to log some innings for the Vikings in their first year.

Hathaway paced the Viking offense, slugging her way to a .440 batting average in about

half of the season. She was followed by fellow battery mate, junior Amanda Carter who hit for a .347 average with nine doubles, five home runs and 25 RBl's. Then the impact of the freshmen in 2008 was seen. Cyndi Figol, Bre-Ann Robertson and Jane Pettit all rounded out the .300 hitting club, batting .339, .333 and .308 respectively. The freshman trio also combined to score 109 runs between the three of them and drove in 86 runs. Junior Lacey Hauser was not far behind hitting for a .292 average with 19 runs scored and 14 RBl's.

"I think that as freshmen we made a successful transition to the college level," explained Robertson. "We were fortunate to get valuable experience in all kinds of situations that will help us be ready for this year." Also back from last year's team are senior Lara Loomis, sophomores Margaret Wilson, Cora Mikkelson and Mandy Johnson. All players gained valuable experience and contributed in the 2008 season, setting them up for success this season.

Along with Smith and Shadlock, newcomers to this year's team include Amanda Brown, Alex

Lanz, Sara Gullickson, Ashley Mayry, Brittney Robertson, Kate Swanson and red-shirt freshman Erika Calkins. Carly Holub will red shirt in the 2009 season. Slyter believes that this year's recruits will contribute just as the freshman did in 2008. "I really believe we have added great talent and depth to an already talented group. This year's class will contribute and add speed to the lineup, speed that was lacking on last year's squad.

"We were very competitive last year in a lot of games, losing a number of games by one or two runs. Our goal this year is to be consistent offensively to produce runs and allow our pitchers to relax and throw strikes. I also believe that our defense will be much improved as well. With good health, I think this group has the leadership, talent and attitude to compete with any team in the DAC and we are looking forward to a great season," Slyter concluded.

## **VCSU Music Hall of Fame Recognition Banquet**

The Music Hall of Fame Recognition Banquet will be held on Saturday, May 9, at the Valley City Town & Country Club, honoring two outstanding VCSU music alumni: Josephine (Wright) Rhoades '17 (in memoriam) and Carole (Paulson) Flatau '60. All VCSU alumni are invited to attend this special event to honor these exceptional women. A social hour will begin at 6:00 pm with dinner served at 6:30 pm. The evening will be filled with memories and stories, celebrating the service of these distinguished individuals to Valley City State University and the musical culture of North Dakota and beyond.

Josephine Wright Rhoades attended the Valley City Normal School, where she later served as instructor of piano and accompanist for the department, as well as for nearly every musical group in Valley City. One of her compositions won the 1916 All North Dakota Song Contest. Perhaps Ms. Rhoades' greatest contribution to Valley City State University is her composition of the words and music of VCSU's Alma Mater. She was a member of the Valley City Music Club (an affiliate of the National Federation of Music Clubs), a church musician at Epworth United Methodist Church, and recipient of a Distinguished Service Award from KOVC Broadcasting Company in 1953.

She moved to California in the 1960s where she continued to be active in the Methodist Church and as an accompanist. Ms. Wright died at the age of 87, after over 70 years of contributions to the music profession. She was married to Louis D. Rhoades, who taught at VCSU from 1919-1961, and for whom the VCSU Rhoades Science Center is named.

Carole Flatau has had a long and distinguished career in music. Her career began in Valley City where she served as an independent piano teacher and church organist until 1985. She then moved to Florida where she accepted the prestigious positions of Director of Keyboard Publications for Columbia Pictures and later Music Editor at Belwin/CPP and Warner Brothers. In 2000, she returned to Valley City where she now operates an independent music studio, serves as an organist at Epworth United Methodist Church, and is a free-lance editor and composer. She owns her own music publishing company, Noteworthy Publications. Flatau was recognized as the North Dakota Music Teachers Association Teacher of the Year in 2002 and as a Music Teachers National Association Foundation Fellow in 2005. She is nationally recognized as an advocate for traditional American music, including folk songs and patriotic music.
